# III. Amend the City Zoning Code – to allow smaller, higher density single family lots in newly proposed and developed subdivision – T. Pettit

D. Tim Pettit stated that when someone submits for a subdivision they are required to have a CCR and HOA for approval. We have to make sure their minimum standards are stricter than ours are. If they are not, we may regulate them.

deal, where they will build small homes regulated by HOA and improved by the Commissioners. This zoning is not a RV park or a mobile home park or on a golf course. We will not allow for any RVs, or boats parked on property. All properties will have parking garage and 1 other parking area, we will have restrictions and the City will oversee. The part of the developer pressuring us, this is not correct, this is expanding our community.

Commissioner Schmidt stated his concern that building smaller homes impact the socialization of the community and he has seen it many times in the past. Does the City want to see this socialization decline happen to our City? Chairman Williams stated that the HOA regulation will assist with that and we will discuss more at our next "Work Session".

Commissioner Brutvan stated with the 4000 sq. ft. lot this includes open space but could allow for a larger home, but we will have the option to review each build and monitor so that we do not get in the situation as Commissioner Schmidt addressed.

Commissioner Brutvan motioned to table this discussion for our next P&Z meeting and to include another "Work Session" to be held at 6:00 pm prior to the regular scheduled P&Z meeting on May 17, 2018. Commissioner Schmidt seconded, and is carried.
