**Note 1. Summary of Significant Accounting Policies**

---

The Annual Expenditure Limitation Report (AELR) is presented on the basis of accounting prescribed by the *Uniform Expenditure Reporting System* (UERS), as required by Arizona Revised Statutes §41-1279.07, and in accordance with the voter-approved alternative expenditure limitation plan extended December 10, 2009 as authorized by the Arizona Constitution, Article IX, §20 (9).

In accordance with the UERS requirements, a note to the AELR is presented below for any exclusion claimed in part II and each deduction or addition in the Reconciliation that cannot be traced directly to an amount reported in the annual financial statements. All references to financial statement amounts in the following notes refer to the Statement of Revenues, Expenditures, and Changes in Fund Balances for the Governmental Funds, Statement of Revenues, Expenses, and Changes in Net Position for the Proprietary Funds, Statement of Cash Flows for the Proprietary Funds, and the Statement of Changes in Fiduciary Net Position.

**Note 2. Reconciliation**

---

The addition of \$1,832,378 for principal payments on long-term debt in the Enterprise Funds consists of principal payments on bonds, loans payable, and capital leases as listed in the long-term debt footnote. The addition of \$4,529,770 for acquisition of capital assets consists mainly of system improvements in the water/sewer fund. The subtraction of \$808,763 consists of a road project that was solely administered by the Arizona Department of Transportation for the City of Williams. The road is owned by the City of Williams. Therefore, the City recognized both revenue and expenditures on their financial statements for the costs related to this project. However, since the project was fully administered by ADOT, which included the paying all related expenditures, this item has been included as a reconciling item on this report.

**Note 3. Exclusions**

---

Exclusions from local revenues, including those enumerated in the Constitution, may be taken against alternative expenditure limitations only if such exclusions are specifically identified in the resolution and the publicity pamphlet. The City's most current resolution does not specify any exclusions and therefore, no exclusions are reported within this document.
